Lt. Gen. Brian T. Kelly, USAF (Ret), is a native of New Jersey. He earned his bachelor's degree in aerospace engineering from the University of Notre Dame and holds two master's degrees, one in national resource strategy from National Defense University and another in military operational arts and sciences from Air University.

Kelly joined the Air Force in 1989, as a graduate of Notre Dame's ROTC program. In his 33-year Air Force career, Kelly served in a number of key command and staff positions, including commander, 92nd Mission Support Squadron, Fairchild AFB, Wash.; deputy director, manpower and personnel, Multi-National Security Transition Command, Iraq; director, manpower, personnel and administration, U.S. Southern Command, Fla.; commander, 31st Mission Support Aviano Base, Group. Air Italy: commander, 501st Combat Support Wing, Alconbury, U.K.; RAF director, manpower, personnel and services, Air Combat Command, JB Langley-Eustis, Va.; director, military force management policy for deputy chief of staff for manpower, personnel and services at the Pentagon; and commander, Air Force Personnel Center, JB San Antonio-Randolph, Texas.

At the time of his service retirement in 2022, Kelly had completed 3<sup>1</sup>/<sub>2</sub> years serving as the Air Force's deputy chief of staff for manpower, personnel, and services at the Pentagon. Kelly took over as MOAA's president and CEO in January 2023.

He's part of a dual-military couple: He and his wife, former **Maj. Garrety Kelly**, **USAF**, met while stationed at SOUTHCOM. ### LEGISLATIVE COMMITTEE REPORT By LTC Gary Battles, USAR (Ret), Co-Legislative Committee Chair

Latest Continuing Resolution Would Move Budget Deadline into 2024: With zero of the 12 appropriations bills needed to fully fund the government signed into law, Congress resorted to another continuing resolution (CR) to avoid a federal shutdown, with the House passing the year's second CR 336-95 on Nov. 14 and the Senate passing it 87-11 late Nov. 15, two days before the first CR expires.

The new CR, with no anticipated policy changes or spending reductions, features two distinct expiration dates extending the appropriations and authorities of the 12 FY 2023 spending bills: Jan. 19 for Agriculture. Energy-Water, Military Construction-VA, and Transportation-HUD; and Feb. 2 for Defense, Homeland Security, Labor-HHS-Education, Commerce-Justice-Science, Financial Services. Interior-Environment, Legislative Branch, and State-Foreign Operations. The White House had indicated the president will sign the legislation into law.

While MOAA supports the CR in lieu of a shutdown, relying on extensions instead of passing a full budget comes at a significant cost:

• Underfunded programs, benefits, and services: By extending the funding expiration dates into the new year, federal agencies overseeing the eight uniformed services lack the authorizations or funding necessary for crucial elements such as the annual military pay raise, quality health care coverage, and quality-oflife programs for servicemembers and their families.

- **Time crunch:** The new expiration dates compress the timeline for federal agencies to spend funds and implement programs that will be outlined in the FY 2024 regular appropriation bills.
- Looming budget cuts: Failure by Congress to pass a budget by the start of the new year would pose a significant threat to all federal agencies and the programs vital to supporting the uniformed services and veteran communities. If all 12 regular appropriation bills for FY 2024 are not signed into law by Jan. 1, it would trigger an *automatic 1% funding cut across all departments*, with no exception for DoD or the VA.

No More Delays – Ask Congress to Come Together to Protect Servicemembers' Pay: While Congress has completed it work on the short-term funding fix to prevent what would be a disastrous shutdown, it's long past time for lawmakers to set aside their differences and ensure all those in uniform, and all retired servicemembers, continue to receive pay during any lapse in federal funding.

The Pay Our Troops Act (<u>H.R. 5641</u>), and Pay Our Military Act (<u>H.R. 5667/S. 2835</u>) are strong starts toward this goal. Much of the text for these bills is similar to <u>2013 legislation</u> necessary to ensure servicemembers were paid during previous shutdowns; the decade-old legislation applied only to the 2014 fiscal calendar and must be renewed.

Recent legislation includes protection for the Coast Guard, but unfortunately leaves out members of the U.S. Public Health Service and National Oceanic and Atmospheric Administration – an unfortunate, but common, oversight MOAA has flagged in discussions with lawmakers. It also does not address what a shutdown could mean for USPHS and NOAA retirees, who are not covered by the <u>Military Retirement Trust</u> <u>Fund</u> and could miss paychecks as a result. <u>The Military Coalition</u> (TMC), of which MOAA is a founding member, is a group of 35 military and veterans service organizations (MSO/VSOs) that pools advocacy power and has continued to send a clear message to Congress to pass appropriations on time, protect servicemember pay, and improve the quality of life of those in uniform and their families.

"Many of uniformed our servicemembers are under financial stress. and endure unacceptable housing conditions and food insecurity, while our nation faces a recruiting crisis," TMC President CW4 Jack Du Teil, USA (Ret), said. "Servicemember pay raises fell 2.6% behind the Employment Cost Index from 2014-16, and Basic Allowance for Housing was reduced 5%, all as costsaving measures on the backs of our uniformed community. The threat of not receiving a paycheck is unacceptable for the members of our eight uniformed services.

"We urge Congress to rapidly pass the Pay our Troops Act before a lapse in appropriations. Missing a paycheck is a stress our servicemembers should not have to worry about, especially when deployed in harm's way."

Although a bipartisan deal on a continuing resolution (CR) has cleared the House and Senate, it is important to acknowledge these CRs are incredibly wasteful of taxpayer dollars and harmful to our national defense.

A new CR will kick the can down the road and buy time for Congress to pass the 12 appropriation bills for this fiscal year. It will also trigger automatic cuts if the federal government is not funded by the new year.

It is an important time to ask elected officials to put aside their political differences, lead by example, and keep to the schedule. The work on appropriations should have been complete before Congress went on summer recess, and it is still incomplete. Our uniformed servicemembers do not have the luxury of going on recess or vacation when their mission is not complete, and Congress should stay in session, suspend all travel, and get the job done.

Lessening the Impact of TRICARE Fee Hikes: MOAA has MOAA has long fought legislation that would burden TRICARE beneficiaries with additional costs as a way to address budget shortfalls in other areas. As Congress considered potential military health system reforms, MOAA was instrumental in:

- Locking the <u>Military Compensation and Retirement</u> <u>Modernization Commission</u> health care proposal to eliminate TRICARE and replace it with a selection of commercial health plans including monthly premiums and significantly higher out-of-pocket costs for working-age retirees.
- Grandfathering servicemembers and retirees who entered service before Jan. 1, 2018, from TRICARE retiree enrollment fee increases (\$450 individual/\$900 family for Select) and a new nonnetwork deductible (\$300 individual/\$600 family) imposed on new entrants.
- Fighting multiple attempts to eliminate grandfathering (included in FY 2018 administration budget proposal and provisions in the Senate versions of the FY 2018 and <u>2019 NDAAs</u>) which would have resulted in higher out-of-pocket costs for Group A/grandfathered retirees.
